- Our Produce on Demand Systems (PODS) is a national program to create Veteran–focused hi-tech food production operations.
- We are flexible to meet crop production requirements for any location.
- Start with specialty crops and expand out and up with greenhouses
- Beginning each location by establishing a local growing footprint using our PODS, we can create any size and type of master-planned environment suitable for growing in a specific geographical area.

PODS MODULAR GROWING SYSTEMS

Revenue Generation

As a stand-alone option, or in advance of, and in parallel with the development and construction of a 15-acre renewable powered high-tech glass greenhouse, ACTS Freedom Farms will utilize the rapid deployment of Carbon Zero PODS, a modular self-contained growing system.

This approach will enable growing and revenue generation in as little as 90 days of contract execution. This model will minimize capital investment, mitigate growing risk, conserve resources, and limit operating expenses



Local Operations

A successful launch of a local growing operation is achieved with minimal capital investment enabling year-round growing with the following advantages of modular, controlled growing environments:

- ✓ Resource Conservation: reduced land and water required for success.
- ✓ **Flexible Siting:** PODS can be sited on any flat surface.
- ✓ Ease of Use: structured training and remote monitoring and management ensures success.
- ✓ **Time to Market:** produce is grown within 90 days of contract execution.
- ✓ Low Market Entry Costs: solves the issue of a lack of balance sheet for new operations.

Flexible Growing Operations

- ACTS Freedom Farms Carbon Zero PODS are designed for the unique requirements of each location.
- Management of the entire capital stack for the facility construction, implement world-class systems and provide ongoing operations and maintenance services to optimize facility performance.
- Non-permanent growing systems simplify the initial market entrance and facilitate the development of retail customer relationships.
- PODS are in concert with renewable powered, high-tech glass greenhouses which provide a platform that is both flexible and expansive.
- Leveraging a PODS environment provides a clear path to near-term revenue during the development and construction process for the renewable powered, high tech glass greenhouse.







RAPID SCALE STRATEGY

Modular Farm Launch

- While every market targeted presents different opportunities and challenges, our structured approach to market expansion will mitigate risk and create economies of scale.
- PODS are either a temporary or permanent solution to year-round production.

Expandable Footprint

ACTS Freedom Farms has identified the top ten markets as the fastest path to market penetration, revenue generation, brand recognition, retail relationships and the development of local growing expertise.

LARGE PRODUCTION

High-Tech Greenhouse

- PODS will scale towards the build out of a 5-15-acre high-tech greenhouse facility in each of the top ten markets identified.
- Once a greenhouse is built, PODS offer flexibility for the local grow operations.
- PODS can either continue growing specialty crops, turn into packing and storage facilities, warehouse, or use them for nursery operations.

CONCLUSION

- ACTS Freedom Farms forecasts \$ 838,976
 minimum revenue per PODS location for the
 first 10 markets which creates over \$8.3M in top
 line revenue.
- The software to monitor and manage the PODS will ensure the successful launch and performance of each grow operation.
- PODS will demonstrate an ability to grow indoors and build local retail customer relationships and brand recognition.



BUSINESS OPPORTUNITY

The ACTS Freedom Farms PODS Program has been designed to allow quick entry into any given market with minimal capital infusion and the shortest timeframe to revenue from production.

Interested parties may assist in any one or more of the following roles to ensure the success of the PODS Program in their marketplace.



LAND ACQUISITION

- A single PODS requires 3,000 SF and additional space for access, servicing, packaging of produce, etc. Therefore, approximately 1/4 acre is ideal.
- If additional PODS were to be placed on the same site, it is likely that 1/8 of an acre will suffice per PODS.
- Land can be purchased outright or through a Lease/Option.
- However, a long-term lease will also serve the need.
- Either fair market values can be negotiated or the provider of the land may receive an equity position in the POD LLC.

CAPITAL REQUIREMENTS

- The first year's operational capital requirements are \$300,000.
- This is structured as debt with a 7-year payout including 6% interest, amortized.
- The person(s) responsible for providing this funding will also receive an equity position in the LLC.
- The infusion schedule will be: \$10,000 upfront to set all startup needs for legal filings, accounting, and structuring of the operation.
- \$90,000 upon execution of the Operating Agreement.
- \$100,000 upon delivery of the PODS to the site. Last \$100,000 upon setting up of the POD and growing systems at the time planting is ready.
- If this disbursement schedule is used, the Funder shall receive 5% ownership in the LLC. Should Funder provide entire \$300,000 upon execution of the Operating Agreement, the same repayment terms and interest will be applied, but the ownership will increase to 7%.
- The lease terms for the PODS will be 7 years P&I amortized, with a \$1 buyout. Although the structuring of the lease lies fully upon the LLC, the signatory for the lease will be assured that payments will be made on time as structured in the payment schedule.

EQUITY POSITIONS

- For the signatory to qualify for the 100% lease, the signatory shall receive an equity position of 10% of the LLC. (It is likely that anyone holding more than 20% ownership in the LLC will be required to sign as a guarantor on the lease)
- Additional participants may also qualify for an equity position in the POD LLC and shall be negotiated as needed.
- ACTS Freedom Farms of America will hold a 19% equity position but will transfer its rights to disbursement of dividends to the local ACTS Freedom Farms LLC.
- The Local ACTS Freedom Farms LLC will hold a 19% equity position
- R. Michael Buehler or his assignee will hold a 13% equity position but will transfer his rights to disbursement of dividends to the Local ACTS Freedom Farms LLC.
- The PODS will stand alone as an operation and be established as its' own entity. Should expansion of PODS become necessary, the current ownership shall have first right of participation, if rejected then outside sources will be offered the opportunity. Should future greenhouse operations become available, they shall be kept as a separate entity.
- The local ACTS Freedom Farms LLC shall retain the right to control and negotiate all operations of the PODS LLC and greenhouse expansion.
